

# VIDEO CONTEST

## Future of the European Railways

*“We want to move European railway forward and we want to do it together with you. – With innovations that can create better, quieter, more comfortable, more secure and reliably trains we see a bright future for rail transport for both people and goods. Nevertheless, you are the future traveller, so your needs, thoughts and ideas are the most important.*

*Imagine you have two minutes to tell the world how you would you want to shape the future of railways.*

*What changes do you wish for? How would you inspire more young people? What is important for you as a traveller?*

*Take part in the video contest and be part of the future of railways.”*

### WHAT ARE WE LOOKING FOR?

***The contribution can be any kind of video material. Between 60 and 120 seconds and in English. The video should illustrate, explain and visualise the view and thoughts of the creative team and also be able to attract attention and create an emotional reaction from the viewer. The video should also in some way mention at least one innovation made within the Shift2Rail Joint undertaking and how this can lead to the changes that they want to see in the future.***

### RULES:

Eligibility: The competition is open only to those who sign up online and who are between 16 and 26 years old as of the date of entry. The competition is only open to legal residents of a country in the European Union and is void where prohibited by law. Employees of TER4RAIL their respective affiliates, subsidiaries, advertising and promotion agencies, suppliers and their immediate family members and/or those living in the same household of each are not eligible to participate in the Video competition.

Agreement to Rules: By participating, you agree to be fully unconditionally bound by these Rules, and you represent and warrant that you meet the eligibility requirements set forth herein. In addition, you agree to accept the decisions of TER4RAIL, as final and binding as it relates to the content.

Competition Period: Entries will be accepted online starting on or about April 20, 2020 10:36 AM and ending August 31, 2020 12:00 AM. All online entries must be received by August 31, 2020 12:00 AM.

How to Enter: The Competition must be entered by submitting an entry using the online form provided on this site. The entry must fulfil all requirements, as specified, to be eligible to win a prize. Entries that are not complete or do not adhere to the rules or specifications may be disqualified at the sole discretion of TER4RAIL. You may enter only once and you must fill in the information requested. You may not enter more times than indicated by using multiple email addresses, identities or devices in an attempt to circumvent the rules. If you use fraudulent methods or otherwise attempt to circumvent the rules your submission may be removed from eligibility at the sole discretion of TER4RAIL.

## WHAT ARE WE LOOKING FOR?

The contribution can be any kind of a video material. Between 60 and 120 seconds and in English. The video should illustrate, explain and visualize the view and thoughts of the creating team on how they would want to shape the future of railways. *What changes do they wish for? How would they inspire more young people? What is important for them as a traveller?*

The video should also be able to attract attention and create an emotional reaction from the viewer. The submission should mention at least once, an innovation made within the Shift2Rail Joint undertaking and how this can lead to the changes that they want to see in the future.

## Applications

A team, with maximum of four participants (between 16- 26 years) from a European country (EU28), enters the first round of the competition with a graphic submission/video. They upload their video to Youtube, Vimeo or Instagram and then insert it to the competition webpage via an upload registration page. The participation is free of charge and one team can only upload one video. The copyright of the materials submitted for this competition remains with respective participants.

However, each entrant grants the Shift2Rail and its partners the right to use the submitted materials in its communication crediting the copyright owners.

The team registers on the contest website with their names and submits their contribution. The applications will go through a digital voting procedure. The selection will be based on voting from an appointed jury and an open digital voting system. 60% of the outcome of the selected finalist will be based on the jury and 40% on the digital open votes.

Prizes: Winners will receive Interrail tickets.

- 1st prize: Interrail tickets for 22days continuous Global Interrail Passes, 1st class provided by Eurail. 1 ticket for each team members, maximum 4 tickets.
- Public favourite prize: 7 days within one-month Global Interrail Passes, 2nd class provided by Eurail. 1 ticket for each team member, maximum 4 tickets.

Actual/appraised value may differ at time of prize award. The specifics of the prize shall be solely determined by the Sponsor. No cash or other prize substitution permitted. The prize is non-transferable. Any and all prize related expenses, including without limitation any and all federal, state, and/or local taxes shall be the sole responsibility of the winner. No substitution of prize or transfer/assignment of prize to others or request for the cash equivalent by winners is permitted.

Winner selection and notification: Winners of the competition will be selected in a voting system, with a jury and public voting, supervision of the Sponsor. The applications will go through a digital voting procedure. The selection will be based on voting from an appointed jury and an open digital voting system. 60% of the outcome of the selected finalist will be based on the jury and 40% on the digital open votes. Winners will be notified via email to the email address they entered, within five (5) days following the winner selection. TER4RAIL shall have no liability for a winner's failure to receive notices due to winners' spam, junk e-mail or other security settings or for winners' provision of incorrect or otherwise non-functioning contact information. If the selected winner cannot be contacted, is ineligible, fails to claim the prize within 15 days from the time award notification was sent, or fails to timely return a completed and executed declaration and releases as required, prize may be forfeited and an alternate winner selected.

The team can use their own social media channels to share their contribution and get more voters and this way also spread the awareness of the campaign and the competition even more.

From the voting we will get one winning team and one winner of the public favourite price. (The same team can't win both prizes, if the so then the public favourite price will go to the team with the second most public votes)

First price of the competition will be 4 Interrail tickets and the invitation to InnoTrans in September 2020, in Berlin to present the winning material. Should the conference be cancelled or delayed due to the pandemic situation or other , TER4RAIL and Shift2Rail have the right to cancel or postpone also the winners presentation and trip.
